Milestone Medical Inc. Announces Distribution Agreement for Epidural Instrument in Poland

LIVINGSTON, NJ, March 23, 2015 -- Milestone Medical Inc. (WAR: MMD) today announced that it has entered into a distribution agreement for its epidural instrument with TRIMED Sp.z.o.o, one of the largest distributors of diagnostic equipment in Poland. In its ten years of operations, TRIMED has built a broad product portfolio for use in gynecology, obstetrics, cardiology, radiology and other medical applications.

Under the agreement, Milestone Medical granted to TRIMED exclusive rights for three years to distribute the CompuFloTM Epidural instrument in Poland, with the rights to renewal, subject to certain conditions being met.

Additionally, the Ministry of Health and the Polish National Health Fund are preparing legislation to allow the reimbursement of epidural anesthesia in natural childbirth."
